In an effort to preserve homeowners' rights and maintain property values, it is required under Article 3.3 of the Bluebonnet Highlands Act of Restrictions that any homeowners, or group of owners, considering improvement(s) to their deeded property, submit a Home Improvement Request Form to the Homeowners Association Council for approval. This must be done PRIOR to initiating work on planned improvements. Examples of improvements include, but are not limited to, exterior paint, additions, outside buildings, fences, driveways, pools and decks. If any change is made that has not been approved, the Council has the right to require the homeowner to remove the improvement from his property.
